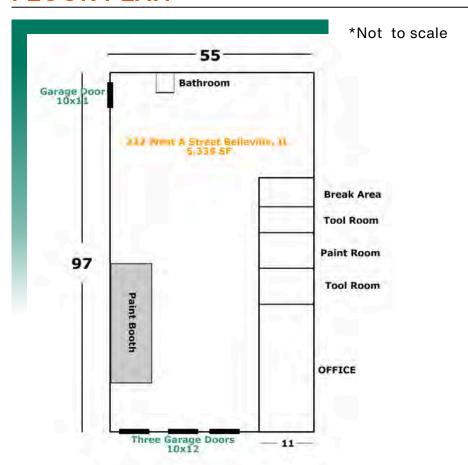


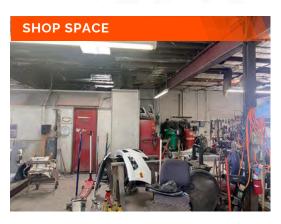
## **LOCATION OVERVIEW**
